Congratulations on choosing Kazakhstan!

Traveling to Kazakhstan to adopt is an exciting beginning to a new life with a new family member.

Kazakhstan requests that each prospective adoptive family keep your emotional and personal focus on the adoption of your child. European Adoption Consultants believes similarly, and the following regulations pertain to same. Please read and indicate your understanding and acceptance by signing and returning to EAC **with this registration packet**.

1. No person other than the adoptive parent(s) are permitted to travel to the region. Children, family members and friends must stay in Almaty. Processing of visa and travel arrangements for additional family member is handled through EAC at a fee of \$75.00 per day per person. However, if you are a single parent and one other person is traveling with you, this fee will not be assessed.
2. No person other than adoptive parents may visit the region and orphanage. Children, family members and friends must stay in Almaty.
3. No person other than the adoptive parents are permitted in Court.
4. There is a fee of \$75.00 per day, per person that me be assessed each family that brings other family members to Kazakhstan. This covers travel to and from airport, access to the EAC family lounge, and all other services available to and expended for that family. This fee is paid prior to travel.
5. European Adoption Consultants cannot arrange baby sitting services, sight seeing services, or other amenities of this nature for additional travelers. We can provide you with the name of a service.
6. Vans are used for transportation of families *only*.
