

**PARENTAL POST PLACEMENT AND CONSULATE REGISTRATION OBLIGATION**  
**to submit postplacement reports and written verification of registration of the Russian citizen**  
**adopted by foreign citizens with the consular facility of the Russian Federation**

1. Undertake obligation to allow representatives of our country and of the Russian Federation to carry out postplacement supervision for the Russian adopted child(ren), to prepare and submit postplacement reports in accordance with the legislation of the Russian Federation, as follows:
  - 1<sup>st</sup> postplacement visit will take place after 5 months has elapsed from the effective date of the adoption decree, and Report #1 will be submitted before the end of the 7<sup>th</sup> month after the effective date of the adoption decree.
  - 2<sup>nd</sup> postplacement visit will take place after 11 months has elapsed from the effective date of the adoption decree, and Report #2 will be submitted before the end of the 13<sup>th</sup> month after the effective date of the adoption decree.
  - 3<sup>rd</sup> postplacement visit will take place after 23 months has elapsed from the effective date of the adoption decree, and Report #3 will be submitted before the end of the 25<sup>th</sup> month after the effective date of the adoption decree.
  - 4<sup>st</sup> postplacement visit will take place after 35 months has elapsed from the effective date of the adoption decree, and Report #4 will be submitted before the end of the 37<sup>th</sup> month after the effective date of the adoption decree.

In addition, should it prove necessary, to submit postplacement reports from the time the three years after the effective date of the adoption decree have elapsed and till the child reaches the age of majority, in compliance with a decision of the body of executive power of the subject of the Russian Federation made in view of the specific situation in the adoptive family.

2. I/We undertake:

- To provide for registration of the minor citizen(s) of the Russian Federation adopted by me/us with the consular facility of the Russian Federation located in the consular district where the adoptive parents are residing, or, in the absence of such facility, with a diplomatic representation of the Russian Federation within three months from the date of the adopted child(ren)'s entry in the country of the adoptive parents' residence, the following documents:
  - application to have the child(ren) registered with the consulate + 2 pictures of the child (ren);
  - certificate of adoption;
  - ID for the adoptive parent(s) and the child(ren).
- To provide a written verification of the adopted child's registration with the consular facility of the Russian Federation or a copy of the child's passport with a note made of his/her registration with the consular facility of the Russian Federation within one month from such registration.
- In case I/we change my (our) residence, to inform the consular facility of the Russian Federation located in the consular district where the adoptive parents are residing, or, in the absence of such facility, the diplomatic representation of the Russian Federation where the child(ren) is (are) registered, and to register him (her, them) with the consular facility or the diplomatic representation of the Russian Federation at the new place of residence.
